

## Official Rules

### American Dairy Association North East/NYCDOE Office of Food and Nutrition Services New York Thursdays Dairy Farm Video Sweepstakes, 2020

No purchase necessary to enter or win a prize for your school. A purchase will not increase your school's chances of winning. The Sweepstakes is sponsored by American Dairy Association North East and the New York City Department of Education's ("NYCDOE") Office of Food and Nutrition Services (OFNS) ("Sponsors"). Void where prohibited.

#### NOTICE:

*This sweepstakes is intended for participation in the United States only and shall be construed and evaluated only according to United States law and New York State law. Do not proceed in this sweepstakes if you are not a legal resident of the United States, or if you do not fall within the eligibility requirements set forth in the Official Rules below.*

#### 1. CAN I PARTICIPATE?

This event is open to all students enrolled in NYC public schools that are participating in the New York Thursdays Dairy Farm Video Promotion. Employees of American Dairy Association North East, National Dairy Council, NYCDOE's OFNS, their respective parents, affiliates, subsidiaries, advertising or promotion agencies or other individuals engaged in the development, production, or distribution of promotional materials and persons who are immediate family members of or who reside in the same household as persons in the preceding categories are not eligible to submit entries on behalf of any participating school.

#### 2. HOW DO I ENTER FOR MY SCHOOL?

The Sweepstakes begins on March 12, 2020 and ends on April 24, 2020 (the "Promotion Period"). To enter for your school, go to [www.MilkVids.com](http://www.MilkVids.com). You will be prompted to watch a New York State Dairy Farm Video. At the end of the video, you will then have the opportunity to find the name of your participating New York City public school, select it and submit. By submitting this information, your school will earn credit for one "View." If your school is credited with a minimum of 50 qualifying "Views," your school will be automatically entered into a random drawing for the Prize (defined below) from among all eligible entries received. Schools that do not reach a total of at least 50 qualifying "Views" during the Promotion Period will not be eligible for the drawing. All entries must be submitted on the website, during the Promotion Period, according to all applicable directions as listed on the website, or the entry will be void. Those who do not fill in all the required fields will be disqualified. This Sweepstakes is void where prohibited or restricted by law. The winning schools will be notified via telephone, mail and/or email and will be subject to verification by Sponsors. If a potentially winning school is determined to be ineligible, an alternate winning school may be selected, at Sponsors' sole discretion.

#### 3. WHAT CAN MY SCHOOL WIN?

All prizes are awarded through Random Drawings involving all eligible schools, divided into three (3) school types: High School, Middle School and Elementary School. One (1) prize will be awarded for each school type, and participating schools may become eligible to win prizes as follows:

High School Prize: One (1) **Cafeteria Makeover** to help you to feature local dairy, fruits and vegetables. Approximate Retail Value (ARV): up to \$5,000. Middle School Prize: One (1) **New York Farm Tour** for an up-close look at where your school's food comes from. ARV: up to \$5,000. Elementary School: One (1) **"Build-A-Garden" Kit** for growing your school's own vegetables and fruits. ARV: up to \$5,000. Odds of winning are based on the total number of schools that achieve eligibility through accumulation of online video "Views."

Winning schools will be announced on or about May 5, 2020. Prizes will be awarded in June of 2020. No substitution or transfer of prize or cash redemption is permitted. Sponsors may, at their sole option and discretion, substitute another prize they believe is of equal or greater value. Taxes, if any, are solely the winners' responsibility.

Sponsors will collect NO personally identifiable information about any student through their participation in this Sweepstakes. Each participant's action only serves to tally one video "View" for his/her respective school.

#### 6. LIMITATIONS ON LIABILITY/OTHER REQUIREMENTS

All entrants, as a condition of entry, agree to be bound by these Official Rules and the decision of Sponsors. All Prize claims and winner materials will be verified by Sweepstakes judges.
